SMEA is a nonprofit organization governed by a board of elected volunteer Save Mart employees. A Financial Assistance and Recreation Committee are in place to enhance member benefits.

The **GOAL** of the Save Mart Employee Association is to offer:

- Aid to eligible members in need due to a catastrophic event resulting in hardship.
- Discounts to sporting events, member picnics, movies, theme parks, travel, shopping and more.
- Opportunities for college scholarships, holiday meal sponsorships, and more.

Catastrophic Assistance Guidelines

Upon review and recommendation by the Financial Assistance Committee, SMEA may provide monetary assistance to eligible members experiencing a financial hardship that resulted from a current catastrophic event. All SMEA members are eligible to apply for assistance following 90 days of dues paying membership. Eligible members may contact SMEA and/or visit our website for more information on our policies, or to request an application for Emergency Assistance.

Under IRS guidelines, examples of qualifying expenses include, but are not limited to:

- Current medical expenses related to catastrophic injury/illness/disease (Ambulance, ER, Surgery)
- Loss of dependent household family members (expenses when insurance coverage is inadequate)
